Greetings Food Vendor Friends,

The 5<sup>th</sup> annual Mayfest on Main Festival will be held on Main Street, Saturday, May 8, 2010. This one day rain or shine event brings approximately 15,000 to celebrate May and the beginning of summer. Along Main Street, approximately 65 crafters will display their crafts and food vendors will serve a variety of foods. Children will be entertained with a kid's area, while a community stage will offer live music and performances from 10:00 am until 12:30 pm. At 1:00 pm the main stage will begin and feature some of the best musical talents around.

**Booth Space.** Each 12' x 12' vendor space must be decorated to complement the beach/car show theme of the festival. A limited amount of food vendors will be allowed. Include a picture with exposure of your booth. This is for placement purposes. Photos will be returned when you pick up your information packet.

**Booth Setup/Breakdown.** Please note that spaces will be available for setup Saturday morning beginning at 6:00 am and vendors must be ready to serve by 9:30 am. All vehicles are required to be out of the festival area by 9:00 am. You will be responsible for all booth setup, tear down, supplies, tables, workers, etc. Breakdown will begin promptly at 6:00 pm, no earlier; with the street cleared by 7:30 pm. Each vendor is expected to leave their area free of trash and waste. The City will provide grease receptacles for your use.

**Insurance Requirements.** All food vendors must obtain 'products liability insurance' and name the "City of North Myrtle Beach" as an additional insured. The insurance should read: "The City of North Myrtle Beach, its officers, employees and agents is/are hereby added as additional insured." Proof of 'products liability insurance' is required with the application submission, only after you have received an acceptance letter will you be required to name the City of NMB as an additional insured.

**Vendor License.** Please note there is a mandatory City of NMB Vendor License fee of \$40 for each vendor that may not have one. You may complete and mail-in the enclosed Vendor License Agreement Application if needed. Please mail a separate check for \$40 made payable to the City of North Myrtle Beach.

# READ THE FOLLOWING CAREFULLY BEFORE SUBMITTING YOUR APPLICATION

1. \$225 will buy you a 12' x 12' space. If you require additional space you must purchase an additional 12' x 12' space at \$75 per additional space.
2. Electricity is LIMITED and will be given on a first payment basis (110v only)
3. Food vendors will not be duplicated. We strive for a variety of food. Main entrees limited to 3 per vendor.
4. Food vendors MUST make provisions for taking their trash with them.
5. Grease receptacles will be provided. Any vendor who pours grease down a storm drain will be prosecuted and not invited back.
6. Vendors must furnish their own tables, equipment and signage. You must provide signs displaying the type of food and cost.
7. Vendors must decorate their booth to complement the beach/car show theme.
8. Vendor set-up begins at 6:00 am. Vehicles MUST BE OUT OF THE FESTIVAL AREA BY 9:00 am. After unloading your equipment, re-park your car in a designated public parking area, and then return to your assigned area to set up your booth. A parking map will be included in your vendor information packet.
9. Vendors MUST be set-up and ready to serve by 9:30 am.
10. Breakdown begins at 6:00 pm, no earlier and vendors must be off the street by 7:30 pm. Violators will forfeit their right to future participation in Mayfest on Main.
11. Vendor information packets will be ready for pick-up beginning Tuesday, May 4, 2010 between 8:30 am and 7:00 pm at the J. Bryan Floyd Community Center, 1030 Possum Trot Road, North Myrtle Beach, SC 29582. If vendor packets are not picked up before Friday, May 7, 2010 by 5:00 pm they will be available the morning of the festival at check-in. Vendor packets will not be mailed to vendors due to the time sensitivity of the information.
12. NO REFUNDS - Festival is held rain or shine.
